RELEASE and WAIVER OF CLAIMS

I, individually and/or on behalf of my minor child(ren), hereby release and hold Lido Isle Yacht Club and their officers, trustees, employees, directors, volunteers, and/or others acting on their behalf harmless from negligence and any and all claims that I or my child may have arising from walking home from the Sailing Program during lunch break or at the end of a Program day.

ASSUMPTION OF RISK

I, individually and/or on behalf of any minor child(ren), expressly and specifically assume any and all risk of injury, illness, death, or property damage resulting from allowing my child to walk home from the Sailing Program.

YOU ASSUME THE RISKS

I, individually and on behalf of my minor child(ren), understand that walking home unsupervised may be dangerous. Once I sign, I am saying that I understand the risks involved and accept all of the risks.

INDEMNIFICATION

I, individually and on behalf of my minor child(ren) shall hereby defend and indemnify Lido Isle Yacht Club and their officers, trustees, employees, directors, volunteers, and/or others acting on their behalf from any and all claims arising from allowing my child(ren) to walk home from the Sailing Program.

DURATION

This release will remain in effect for the existing summer, June 22, 2020 through July 30, 2020 and I agree that I will notify Lido Isle Yacht Club in writing if I choose to revoke this authorization.
